

I. Name of Sponsors. CR Neff, Commercial Refrigeration, Triple Nickel Saloon, KAS Windows, Lennox and 101.3 WMCI

II. Eligibility.

Entrants must be legal residents of Illinois, be at least 18 years old, and the owner of the home (single family dwelling) where the furnace will be installed. The home must be located within our service area, defined as within a 35 mile radius of our office in Mattoon, Illinois.

Any individuals (including but not limited to employees, consultants, independent contractors) who have within the past 6-months performed services for CR Neff, any organizations responsible for sponsoring, fulfilling, administering, advertising, or promoting the contest, or supplying the prize, and their respective parent, subsidiary, affiliated, and successor companies, and immediate family and household members such individuals, are not eligible to enter.

V. Prize(s):

The grand prize winner will receive a brand new Lennox Merit Furnace and installation. The installation includes necessary duct modification at the furnace, wiring, and misc. materials for a furnace replacement. Digital thermostat will be included at winner's request. Standard warranty will apply. 10 years parts after registrations. CR Neff will give a 1 year free PSA (Planned Service Agreement) for furnace only. 1 year workmanship warranty also included. CR Neff will also haul away the existing furnace at winner's request.

Material needed for "adding" a furnace, or any additional equipment such as a propane kit, ductwork not at the furnace, chimney liner or modifications, and other non-specified material that would not be part of a standard replacement furnace installation is NOT included in the prize but contestant may choose to add additional items for an upcharge. (*Adding for our purposes is defined as: Installing the unit where a pre-existing furnace was not already installed. Including but not limited to: new construction, boiler replacement, oil furnace, etc.) All expenses not specifically provided herein are the winner's sole responsibility. Some restrictions may apply. Prize must be used as specified or will be forfeited.
